Have you ever tried to fight worry with faith and felt you were losing the battle? Have comments like “God’s got this!” or “Just pray about it” only left you feeling more burdened? Through examples of how God gave

the Israelites victory over their enemies and generously blessed them, too, we'll be victorious in our fight of faith so that we not only radically transform our own lives but unequivocally impact society. A companion six-week Bible study Joshua: Winning the Worry Battle is also available for those who would like to dig deeper into the book's topic. Study components, each available separately, include a Participant Workbook with five days of lessons per week, Leader Guide, and DVD with six 20-25 minute sessions (with closed captioning).

Part IV, "Compliance," examines the most critical processes for the prevention and detection of money laundering and terrorist financing. This section reflects on the practical elements that should be in place so that financial

institutions can comply with AML/CTF requirements; these are categorized into the development and implementation of internal controls, policies and procedures. Part V, "International Cooperation," reviews the compilation of international laws and treaties between countries working together to combat money laundering and terrorist financing. As these unlawful activities can occur in any given country, it is important to identify the international participants who are cooperating to develop methods to obstruct these criminal activities.
