One of the principal aims of this Workshop was to provide a bridge between the electromagnetic device designers, mainly industrialists, and the electromagnetic field computation developers. Therefore, this book contains a continuous spectrum of papers from application of electromagnetic models in industrial design to presentation of new theoretical developments.
