Bing: Property And Casualty Insurance License

Producers: Excess ethics hours will not be credited and will be lost. All other hours may be completed by taking courses approved only for the line of authority in which you hold a license. Combined Life/Health and Property/Casualty producers: the student must complete at least 6 hours (25%) of the 24-hour requirement in each line. The remaining 12 hours may be fulfilled in either line.
